e-Committee Outreach/ Training Programmes Conducted During June 2025



Throughout 2025, June various **Judicial** Academies across India conducted extensive outreach and under the training programs e-Committee. These initiatives were designed to improve the skills and knowledge of judicial officers, court staff, advocates, and administrative

personnel in key areas like handling digital evidence, computer skills, and eCourts procedures. These nationwide initiatives benefited a total of 27,659 participants, highlighting a strong commitment to modernizing the justice system and improving digital skills.

Judicial Training & Research Institute, Allahabad, Uttar Pradesh:

The Judicial Training and Research Institute, Uttar Pradesh, held a training program to update the skills of court staff. On June 26, 2025, the institute conducted the ECT_9_2025 Refresher programme for Court Staff.

This extensive training session was attended by approximately 2000 staff members of the District Judiciary, underscoring a significant effort to enhance their professional capabilities.

Outreach and Training at the Andhra Pradesh Judicial Academy:

The Andhra Pradesh Judicial Academy conducted two key outreach and training programs to improve the skills of both technical staff and legal professionals.

Technical Staff Training: On June 21, 2025, the academy conducted a program titled "Programme for Technical Staff of High Court - Hardware & software maintenance, Data Replication, Data monitoring, VC equipment, Lan connections, etc" (ECT_10_2025). This training session, held at the High Court was attended by 50 Technical Staff and NIC Coordinators. The program focused

on crucial technical skills to ensure the smooth operation and maintenance of the court's digital infrastructure.

eCourts for Legal **Program** Professionals: A second program, "Advocate/ Advocate Clerk eCourts Programme District at Headquarters" (ECT 4 2025), took place on June 28, 2025. This session was designed to train 694 Advocates and Advocate Clerks on the use of services, helping eCourts them navigate the digital legal system more effectively.

West Bengal Judicial Academy Training Programme:



The West Bengal Judicial Academy organized three distinct training programs to enhance the skills of its Judicial Officers.

Cyber Laws and Digital Evidence
Training: A two-day "Cyber laws &
Appreciation & Handling of Digital
Evidence - Refresher Programme"
(ECT_14_2025) was conducted on
June 16 and June 20, 2025. This
program benefited 42 Judicial
Officers on the nuances of cyber laws
and the proper handling of digital
evidence, a crucial skill in today's
digital age.

Computer Skills Enhancement: On June 18 and June 20, 2025, the academy held a "Computer Skill enhancement Programme - Level I & II" (ECT_13_2025). The training session was attended by 42 Judicial Officers from the District Judiciary and aimed to improve their proficiency in computer operations.

eCourts Program: The "eCourts Programme at All-District Headquarters" (ECT_16_2025) was held on June 13, 2025, for 28 Judicial Officers of the District. This program familiarized the Judicial Officers with the eCourts platform, streamlining their judicial processes.

Chhattisgarh State Judicial Academy:



The Chhattisgarh State Judicial Academy organized two important training programs in June 2025 to enhance the skills of legal and administrative professionals.

eCourts Training for Advocates: On June 14, 2025, the academy conducted two sessions of "Advocate/ Advocate Clerk eCourts Programme at Taluk /Village" (ECT_7_2025). These sessions provided essential training

on eCourts procedures for 77
Advocates and Advocate Clerks.

Administrative and Management Training: On June 29, 2025, a "Programme for Court Managers & Administrative Head Staffs of District Judiciary" (ECT_5_2025) was held. 51 Administrative Head Staff and Court Managers participated from every district, focusing on enhancing their management and administrative capabilities.

Delhi Judicial Academy: Refresher Programme for Court Staff



The Delhi Judicial Academy organized a refresher program for court staff on June 11, 2025. The "Refresher programme for Court Staff" (ECT_9_2025) was attended by 100 staff members of the District

Judiciary. The program focused on key topics related to the eCourts project, including Data Management, Process Management, and other relevant areas to enhance efficiency and digital proficiency.

Himachal Pradesh Judicial Academy: Training Programs for Court Staff

The Himachal Pradesh Judicial Academy conducted two distinct training programs to improve the skills of its court staff.

Refresher for **Programme** Administrative Staff and Process Servers: On June 9 and 10, 2025, the academy hosted a two-day refresher "Refresher titled program programme for Court Staff & Nstep Training" (ECT 08 2024). This training session was attended by 29 participants Administrative Heads, Nazarat, and Process Servers. The program was designed to improve

their skills in using the CIS and Nstep systems.

Refresher Programme for District Judiciary Staff: The "Refresher for Staff" programme Court (ECT 09 2024), was held from June 27 to 28, 2025. This session was attended by 25 staff members of the District Judiciary. The program focused on providing comprehensive refresher on relevant topics to improve their daily work efficiency in efiling, ICJS and other eCourts related topics for easy access to the services.

Jharkhand Judicial Academy: eCourts Programme for Judicial Officer:

In June 2025, the Jharkhand Judicial Academy organized a training program aimed at improving the digital skills of its judicial officers. On June 20, 2025, the academy conducted ECT_16_2025 at District Headquarters. This session was

attended by 151 Judicial Officers, who gained valuable skills and knowledge on the eCourts platform. The program's goal was to streamline judicial processes and boost overall efficiency.

Assam Judicial Academy- Training Programs for Administrative Staff & Court Staff:

Training for Administrative Staff:



On June 8, 2025, the academy held a "Programme for Court Managers & Administrative Head Staffs of District Judiciary" (ECT_5_2025). This program was attended by 60

Administrative Head staff and Court Managers from every district, focusing on enhancing their management capabilities.

Refresher Programme for Court Personnel:



A "Refresher programme for Court Staff & Nstep Training" (ECT_8_2025) was conducted on June 18, 2025. The session saw the participation of 407 staff, including Administrative heads, Nazarat, and Process servers, aiming to refresh their knowledge and skills for more efficient court operations.

Arunachal Pradesh, Assam Judicial Academy: Training for Administrative Staff



The Arunachal Pradesh, Assam Judicial Academy held a training June 8, 2025, for program on administrative staff from across the region's districts. The program, titled "Programme for Court Managers & Administrative Head Staff of District Judiciary" (ECT 5 2025), was designed to improve the skill set of key personnel. A total of 29 Administrative Head staff and Court Managers participated in the session. This initiative aimed to enhance their management capabilities and administrative proficiency, which are crucial for the efficient functioning of the district judiciary.

Madhya Pradesh State Judicial Academy: eCourts Training Programs

On June 21, 2025, the Madhya Pradesh State Judicial Academy conducted training for advocates and their clerks to boost their digital skills.

eCourts Programme at District **Headquarters:** The "Advocate/ Advocate Clerk eCourts Programme Headquarters" District at (ECT_4_2025) was held for 1,500 participants. This session focused on familiarizing them with the eCourts platform at the district level, a crucial toward modernizing step legal practices.

eCourts Programme at Taluk/Village Level: On the same day, the academy also organized the "Advocate/ Advocate Clerk eCourts Taluk /Village" Programme at (ECT 7 2025). This program provided specialized training on eCourts to 1,500 advocates and advocate clerks, focusing on Taluk and village-level applications. This dual approach ensured comprehensive coverage of digital skills for legal professionals across different administrative tiers reached out to stakeholders at field level.

Rajasthan State Judicial Academy: ICT & eCourts Induction Programme

The program was held on June 10- 12, 2025 and June 16-17, 2025. 1,056 participants including advocates and their clerks benefited

from these sessions, which focused on enhancing their digital proficiency for more efficient legal practice.

Refresher Programme for Court Staff: The academy also organized a "Refresher programme for Court Staff" (ECT_9_2025). This program took place on June 12, 13, 18, 23, and 28, 2025. A total of 1,092 staff members attended, refreshing their knowledge and skills to improve operational efficiency and adapt to modern court procedures.

eCourts Programme for Judicial Officers: ECT 16 2025 "eCourts

Programme at All District Headquarters" was conducted for judicial officers. The program was held on four dates: June 13, 18, 23, and 28, 2025. A total of 219 Judicial

Officers participated, ensuring they are well-versed in the eCourts platform and can effectively manage digital court proceedings.

Telangana State Judicial Academy: Training for Administrative Staff



The Telangana State Judicial Academy organised a training program to boost the skills of its administrative personnel. On June 28, 2025, a "Programme for Court Managers & Administrative Head Staffs of District Judiciary"

"Refresher Furthermore, a programme for Court Staff & Nstep Training" (ECT 8 2025) conducted for 6,181 Administrative Heads, Nazarat, and Process Servers, aiming to update their skills and knowledge.

eCourts Programme for Judicial Officers: The "eCourts Programme Headquarters" All-District at (ECT_16_2025) was organized for 979 Judicial Officers of the District. This program focused on equipping them the skills with necessary effectively use the eCourts platform. In this programme, topics like CIS, of Infrastructure computers, Softwares & Hardwares, e-filing, ICJS and pre-trial module were covered.

Tripura Judicial Academy: Refresher Programme for High Court Staff



On June 21, 2025, the Tripura Judicial Academy held a specialized refresher program for the staff of the High Court. The "Refresher programme for Registry Staff of High Courts" (ECT_15_2024) was attended by 33 High Court Staff. 
Meghalaya State Judicial Academy Conducts a Training on ECT_4_2025 and ECT_12_2025 for the Advocates of District Headquarters

Inauguration of Five e-Sewa Kendras at Darbhanga Judgeship of High Court of Patna



Three e-Sewa Kendras at Darbhanga Sadar, One at Sub-divisional Court, Benipur and One at Sub-divisional Court, Biraul were established under the eCourts Project, Phase-III. These eSewa Kendras were inaugurated on 21st day of June, 2025 by Hon'ble Mr. Justice Sandeep Kumar Judge, Patna High Court-cum-Hon'ble The Inspecting Judge Of Darbhanga Judgeship in the august presence of Hon'ble Mr. Justice Chandra Shekhar

Jha Judge, Patna High Court, Patna. The newly established e-Sewa Kendras have enabled the public at large and the litigants to obtain following services:-

- Handling inquiries about case status,
 next date of hearing and other details.
- Facilitate online Applications for certified copies.
- Facilitate e-Filing of petitions right from the scanning of hard copy petitions, appending eSignatures,

- uploading them onto CIS and generation of filing numbers.
- To assist in online purchase of e-Stamp papers/ePayments.
- To help in applying and obtaining Aadhaar based digital signature.
- Publicise and assist in downloading the Mobile App of eCourts for Android and IOS.
- Facilitate in the booking of eMulakat appointments for meeting relatives in jail.
- Handling queries about Judges on leave.
- Guide people on how to avail free legal services from the District Legal

- Service Authority, High Court Legal Service Committee and Supreme Court Legal Service Committee.
- Facilitate disposal of traffic challan in virtual Courts as also online compounding of traffic challans and other petty offences.
- Explaining the method of arranging and holding a video conference court hearing.
- Provide soft copies of judicial orders/judgments via email, WhatsApp or any other available mode.



Integration of Madras High Court's Case Information System with Court Cases Monitoring System Portal



The integration of Madras High Court's Case Information System with Court Cases Monitoring System (CCMS) was implemented in the Principal Seat of Madras High Court and Madurai Bench with effect from 24.11.2021 03.02.2023 and respectively, wherein, USR Number/SR Number and Date of filing of Counter Affidavit, Contempt Petitions, Writ Appeals and Review Petitions are being shared and the Interim Orders/ Judgments are also shared with effect from 01.09.2023. Subsequently, the Under

Secretary, Department, Law of Puducherry Government requested to push the case data pertaining to the Puducherry Government to the CCMS portal of Government of Puducherry (https://law.py.gov.in/ccms/). In this regard, Madras High Court has implemented the integration Madras High Court's Case Information System (CIS) with Court Cases Monitoring System (CCMS) of Government of Puducherry with effect from 16.06.2025.

Recruitment and Appointment of Technical Manpower For 298 E-Sewa Kendras by the Madras High Court



Under the Phase III of eCourts Project (Financial Year 2023-24), 298 eSewa Kendras were established in 250 Court Complexes across the State of Tamil Nadu and U.T. of Puducherry. Further, with regard to deputation of staff, the High Court has recruited and deployed 298 (295+3) Contractual Staffs for the established eSewa Kendras.

Subsequently, based on the recommendation of the High Court, the Government of Tamil Nadu and the Government of Puducherry have issued orders sanctioning 298 posts on contractual basis to provide guidance and support to enhance citizen centric services, addressing their queries and concerns.

Functioning Of Judicial Service Centre/ Centralised Filing Counter At All Court Complexes In District Judiciary Of Rajasthan

RAJASTHAN HIGH COURT

No. 10 / P.I. / 2025

It has been observed that Judicial Service Centres (JSC) and Centralised Filing Centres (CFC) in some court complexes are not fully functional despite having completion of site preparation work as well as availability of requisite hardware.

It is enjoined upon all concerned to ensure that Judicial Service Centres (JSCs) and Centralized Filing Centres (CFCs) in all the Court Complexes are fully operational and effectively functional in accordance with Standard Operating Procedure (SOP) using available infrastructure and space. The JSCs/CFCs shall act as Reception-cum-Inquiry Counters and One-Stop Centres for the centralized filing of cases, applications, and submission of documents by advocates and litigants in the courts situated in a court complex.

The staff deployed at JSCs/CFCs must be adequately trained in handling CIS, eCourts services, and digital fillings. Regular training programmes must be organized through Technical Manpower of the District Court.

The District Judges shall submit half yearly report to the High Court regarding functioning of JSC/CFC in Court Complexes of their judgeship.

Creation of Computer Server Room/ Judicial Service Centres in every Court Complexes at Districts as well as Taluka/ Tehsil Court Complexes have been provisioned under eCourts Project. Chapter As per 4-Infrastructure Model of Policy and Action Plan Document of Phase II of eCourts Project, there have been two components of Sites that is Court Complex namely Judicial Service Centre (JSC) and Computer Server Room (CSR). Computer Server Room (CSR) renamed as Network Room (NR) adopt order the Cloud to Computing Architecture all applications and databases required for the Courts. It has been specified that the Judicial Service Centre (JSC) in the court complex will be utilized as a hub for Reception cum Inquiry

and also as a Central Filing Centre (CFC). In the new Court Complex, the provision of JSC-cum-CFC with sufficient space and civil/ electrical infrastructure will have to be ensured as the primary requirement. A Judicial Service Center (JSC) is a specialized facility or entity that plays essential role in facilitating effective operation of the judicial system at local, district, or national levels. JSC has been provisioned as a part of Site Preparation in a Court Complex with Computer Server Room. These centers aim to make the process more accessible, judicial efficient, and transparent for all stakeholders, including the public, legal professionals, and the courts. There are some of the key details and functions of a Judicial Service Center i.e. Court Administration and Case Management, Public Information and Outreach, Court Filing and Document Technology Management, and Infrastructure Support, Courtroom

and Facility Management. In order to make effective the use of eServices in the Judicial System and establishing One Stop Centre, all the Courts of District Judiciary have been directed for proper functioning of Judicial Service Centre/ Centralized Filing Centre (JSC/CFC) at every Court Complex in accordance with Standard Procedure (SOP) Operating centralized filing of cases, applications & documents by the advocates and litigants and facilitate advocates/ the litigants regarding e-Services. Some services will be available at JSC/CSR i.e. One Stop Centre for centralized filing of Onsite cases, Help Desks eServices like e-filing, e-pay, virtual status, cause list, hearing, case uploaded orders/ judgments, Uniform Classification Methodology, it helps to keep the public informed about ongoing providing cases, transparency and accountability in the judicial process.

eServices Training for New System Assistants and Court Staff at the Rajasthan High Court



The Rajasthan High Court and District Courts have recruited 230 System Assistants. Out of these, 26 have been assigned to each of the High Court's benches in Jodhpur and Jaipur. A total of 456 staff from the High Court's Jaipur and Jodhpur benches received training in June 2025.

Newly Recruited System Assistants:
