SUBMISSION OF APPLICATION:

Candidates are advised to apply and submit their applications strictly through On-Line mode by clicking on the "**Online Application**" icon appearing in the website viz www.meghalayahighcourt.nic.in.

Applications received through any other mode shall not be accepted and will be summarily rejected.

For candidates applying for the first time through On-line mode, a one-time registration process is required to enable them to apply against the advertised vacancies/posts. Kindly read the instructions on the web page carefully before applying online. Last date for online application is 1700 hrs on 4th March, 2020.

Candidates who have already registered with the Recruitment Portal may log in and apply directly against the advertised vacancies/posts of their choice.

Payment for online applications

Application Fees for the said posts for general applicants is **Rs.400/- (Rupees Four hundred)** only and **Rs.200/- (Rupees Two hundred)** only for **Scheduled Caste/ Scheduled Tribe**. Candidates may pay using the following modes.

1. ATM Cum Debit Card issued by State Bank of India or Netbanking of State Bank of India's account holders. Please select ePayment and select State Bank of India in the Meghalaya Portal Page and proceed for payment.
2. Cash payment at any branch of SBI using eChallan: Candidates may also pay by Cash at any branch of SBI. For cash payments using eChallan, select Payment across Bank Counter and generate the eChallan. Take a print out of the same and make the required payments. Payments must be made within 3 days from the last date of receipt of application. The amount once deposited shall not be refunded or adjusted against any other purpose.

A candidate for appointment to the High Court service who is not in permanent Government Service must not be more than 27 (twenty-Seven) years of age in case of General Category candidates and 32 (thirty-two) years of age in case of Scheduled Castes/ Scheduled Tribe candidates at the time of his/her application. No application shall be entertained from a person whose age is less than 18 (eighteen) years.

- b. The last date for submission of application shall be at **1700 hrs. 04.03.2020**
- c. No TA/DA shall be paid to the applicants for attending the examination and personal interview.
