2. Mongsonggipa ra·biani ja·pangde ian 2014 bilsiosa A·dok indake ma·sina man·aha, chong·motan, Meghalaya Treasury Accounts Service-o

kamna rakkiani aro Meghalaya Accounts Service-o kamna rakkiani bewalrang apsangrika maina ia ge gnion, kamo napchengani lekka-pora man-na nangani gadang, kamo ong-engmitingo training on-an i aro kam ka-an i bewalrang apsangrika. Unbaksana, July 1, 2014 tariko nangchongmotgipa u-iatanio ra-chakaniko dakaha indake Meghalaya Treasury Accounts Service-o dangdike on-na minggipin lekka-porako nangdapa maina candidate computer-ko jakkalna sapgipa ong-na nanggen.

3. July 1, 2014 bilsio u-iataniko ja-rikani gita, Meghalaya Treasury Accounts Service-ni ning-o donggipa post ge gittam Accountants, Senior Accounts Assistants aro Junior Accounts Assistant-ni dormahani gadangko (pay scale)` ra-doataha maina iarang Meghalaya Accounts Service-o donggipa post-rang baksa apsangrika. Meghalaya Treasury Accounts Service-ni dakgimin pay-scalerangni level-rangko baridapatani a-sel bang-a dingtang dingtang gualniko Fifth Meghalaya Pay Commission u-in a man-aha ine July 31, 2017 bilsini report-o janapaha. Commission, Meghalaya Subordinate Treasury Accounts Service-na bate chugipa gadango skotong ong-engipa Meghalaya Secretariat Subordinate Service-ni pay-scalerangko skang State Pay Commission tik ka.manaha ine nikaha. Pay-scalerango dingtanggrikaniko u-ie Commission indake nie janapaniko dakaha, “A dok Sorkarini chanchianiko dake rangsan Meghalaya Subordinate Treasury Accounts Service-ni pay scale-rangko baridapataniara dingtang dingtang gualani kamrangko kosako janapgimin gita ong-katataha.

(c) Meghalaya Subordinate Treasury Accounts Service-o dangdike on-engipa manderangni dormahako kosako janappipao pangchake warachakaniko on'na aro ong'chengipa tariko ra'gimin pay aro D.A-ko Meghalaya F.Rs and S.Rs-ni ning-o dakgimin nangchappipa niamrango gita on'na.”

5. Bi'aniko dakenggipani association indake badi ka·aha jensalo 2014 bilsio A·dok Sorkari branch ge gnio dangdike on·engipa manderangni kamrang apsangrika ine nikaha aro jensalo Meghalaya Treasury Accounts Service-na seokao minggipin technical qualification-ko nangchongmota ine A·dok ra·chakahaon, July 1, 2014 bilsio u·iatgipani gita Fifth Pay Commission apsanko dakgruna nangjachim aro dingtangmancha tang·doatani a·selko ra·chakgija dakna nangjachim ine matnangaha. Mongsonggipa bianiko dakanide ian indake a·doko badiaba dangdike on·engipa dolni manderangni ding·chaoanina knachake dolgipin a·doko dangdike on·engipa dolko ra·ongalania kragipa ra·chakani ong·jawa.

6. Bianiko dakenggipa association-ni minggipin ra·chakna man·gijanide ian, Fifth Pay Commission-ni namnike tik ka·e on·ani ja·man A·dokni ra·chake ra·gatatanio, A·dok bi'aniko dakenggipa association-ni member-rangna je bariatgimin dormahakon on·manahachim uako ra·pilna jotton ka·naba gnang aro Meghalaya Accounts Service-o apsangipa gadangni gipin man·engipa pay-scalerang baksa ja·chapatnaba gnang.

7. Skanggipa mamlako niatchenganiko dakanide ian, jensalo kam ka·giparangna ra·dona chanchiani ba uamangni dormahako ba man·gniko (emoluments) baridapatna jechakani gnang, unon judicial-ni gita nipeltaianiko dakani cholde chongkandik ong·aia ine agana man·aigen aro, ramram dake agangenchi mode, executive-ni chanchianirangsa gamchatbata. Indiba, jensalo

chanchianirang ba tik ka-anirang name melijaenga ine nika, unon Kachari gipin cholrangchi uarangko tik dakpilatna man·gen.

8. Da·o ong·engipa mamlao, A·dok sorkari dingtang dingtang gadango kamko ka·engipa manderangna dormahako tik ka·na dingtangmancha songako man·gipa dolni pay-scalerangko tik ka·e tarie on·giminkosa ra·chakmangmangaiaha. Jensalo uandakgipa dingtangmancha dongimin dol a·doko ong·enggipa mamlarangna a·selrangko chanchie mesoke on·a unon A·dok uni bilko jakkale apsanko ra·chaka aro Kachari A·songni niam-retini (Constitution) Article 226-ni ning·o dongimin gita mamingkoba daktejawa. Bon·kamao, ia bilko jakkalanio, Kachari chanchianirangko ra·gatatanina bate chanchina nanggipa kamrangkosa mongsong dakbatgen, jena kingking ua chanchianirang Kachariko jadipchangatjawa ba namen apsangrik ong·gijani ong·atjawa.

9. Pay-scalerangko komiataha ong·ode mamlao dingtangengnokchim. A·songo tarigimin service jurisprudence-ni pay protection-ni ning·o dakgimin niamrang gita, je pay-scalekon dangdikengipa mande ba cadre-na on·ahachim, uko maming dakeba ja·manchi dingtangatna man·taijaha. Da·oni ong·engipa mamlao, July 1, 2014 tariko sokatgipa u·iatanini gita Meghalaya Treasury Accounts Service-ni Accountants, Senior Accounts Assistants aro Junior Accounts Assistants-ni batbegipa pay- scale rangko Rs.30,610/-, Rs.28,780/-, Rs.27,510/-, dake chamanaha. Fifth Pay Commission-ni tarigiminko ja·rikani gita, Meghalaya Treasury Account Service-o ong·engipa Accountants, Senior Accounts Assistants aro Junior Accounts Assistant-rangni man·chengipa

dormahani gadangrang Rs.39,400/-, Rs.37,800/- aro Rs.30,300/-, ong·tokgen.

10. Bi·aniko dakenggipani duk man·enganide ian Meghalaya Accounts Service-ni member-rang an·tangtangni man·na nanganiko rakkie donna man·gijianian ong·a aro uamangna July 1, 2014 tariko u·iatgipani ning·o ra·doatani bidingo Fifth Pay Commisssion-ni apsanko rakkina man·gijianiao mikkango kratcha·aniko ra·baengnaba gnang.

11. Indioba, gnigipa a·selrango mol·molonio maiba namgni gnanganiko nikna man·gen. Fifth Pay Commission-ni ra·chake on·engipa pay-scale rangko a·bachengatgipaoni da·alona ra·gatna nangnaba gnang jekon ra·gatchengatani somoio, Meghalaya Treasury Accounts Service-o kam ka·engiparangna Meghalaya Accounts Service-o apsan post-rango ka·engggiparang baksa apsan on·aha. Uandakgipa obostarang ong·enggon, Adok, Meghalaya Treasury Accounts Service-o dangdike on·engipa manderangna bate on·gimin dormahako badee gama ine a·selko on·e man·pilna jotton ka·naba gnang.

12. Ian rongtalbeen ong·na amgijani ong·a. Jensalo tik ka·gimino pangchake kam ka·engipa ba dangdikengipa manderangna dingtangmancha gadangni dormahako on·engon, gualani ong·genchimoba, on·dapgipa ba badee on·gipa tangkako kam ka·giparang togie ra·a ba ka·engipaskarang ra·draja skalde ua tangkako man·pilna man·jawa. Da·o ong·engipa mamlao, Sorkarian July 1, 2014 tarikni u·iatnio, Meghalaya Treasury Accounts Service-o dangdike on·engiparangko, Meghalaya Accounts Service-o donggipa post-

rang baksa apsan gadango donataha. Meghalaya Treasury Accounts Service-o dangdike on·giparangna Fifth State Pay Commission-ni tik ka·e on·gipako ra·gatani tarik ong·kujana kingking on·gipa dormahako Fifth Pay Commission-ni on·gipana bate badegenchimoba uako man·pilna amjaha maina badee on·aniko Treasury-o kam ka·giparang togie an·tang ra·drajaha ba sakgipin uko ra·china drajaha.
