(c) Miksonge didianiko dakani ba jean je gadangni mande ba je jatni manderangko gipin gadangni mande ba jatni mandeni kosako dosko dakchina didianiko ong'atgen, uana bilsigittamona kingking pattoko donate ba dai gamate ba minggnikon dakate sastikoman'gen.

9. Jeon seachi ba aganachi mangmang jinmako golmal ong'atgen ba tom'tome donganiko nosto ka'gen, indakako champengna niamko ra'gatna nanggen. Tom'tomgijianiko ong'atna ba manderangko bilchi jakchi sokatna ba ka'onangatna didianiara Section 153A IPC-ni ning'o dos ong'a ine ga'akna nangchongmotgipa (*sine qua non*) ong'a aro mamla chusokna gitamiksongani ba u'ie dakmanchaa (*mens rea*) ine prosecution sakkiko man'a nanggen<sup>1</sup>.

10. Section 153A IPC-ni ning'o ga'akgipa dos dakaniko kan'dike aganode dingtang dingtang dolni manderangko bobil ong'atna ba mitchigrikatna jotton ka'anian ong'a. Mongsongbate maidakgipa ku'sikko seanio jakkala aro mai obostao sea aro chapa ka'ata uni miksonganiko nina ba sandina nanga. Section 153A-o ga'akgipa Matnanganiko (Complaint) chu'gimik poraina nanga. Katta rake jakkalao aro badiaba seani bakrangko ra'e potaniko dakna ba sentence mingsa ianiko uaniko dake nangdimate man'gipao pangchake chanchianiko dakna man'ja<sup>2</sup>.

11. **Bilal Ahmed Kaloo v. State of A.P.**<sup>3</sup> mamlao, Section 153 A aro 505 (2) IPC-o dos ong-na nanqipa obostarangko ia Kacharian sandie niaha. Mandeni “Kattachi, aqanachi ba

seachi ba chin dakachi ba nikna man'gipa mesokanirangchi bobil ong'grikate, mitchigrikate ba namnikgrikjianiko ong'atna jotton ka'a ia pilakan Section 153A-o man'gopa ine hukum on'aha. Section 505(2)-o ga'aknade je agananikoba gipatachi ba jangbingbanga kattako ba jajrengatgipa koborrangko on'e chapa ka'atachi indakgipa chanchianiko ong'atna nanga. Section 153A aro Section 505(2)-o dos ga'aknade miksunge ba u'ie daktelna (Mens rea) nanga. Ia section gegnio apsan apsan dakaniara, bobil ong'grikatao, mitchigrikatao ba namnikgrikatgijo dingtang dingtang torom ba jat ba ku'sik, ba dol ba ma'mal ba songsarni gisepo komibeoba dolgni gisepo ong'na nanga. Iana agreba **Bilal Ahmed Kaloo**-o (ra'chapanio skang janapgipa) indakeba hukum on'aha je, jatsa ba dolsako ding'doatmangmange, gipin jat ba dolko janapjaode ia section gegnio ga'akja. Minggni dosrangni dingtanggrikaniko Kachari janapkuaha, indake kattarangko chapa ka'aniko ba agananiko gipate mesokaniko Section 505-o dos ga'akna man'na nanga (*Sine qua non*). Ia Kacharini **Ramesh v. Union of India**<sup>4</sup>-ni mamlao rai on'giminko janapchapaniko nangchongmota, jeon aganario dos daka ine potanina kattarangko aganani bewalko, namen skani gnanganiko, kimkim ong'e agananiko, ka'donggipa mandeni aganani gita niataniko dakna nanga; bilgrigipa ba chanchianiko ra'na changgijagipa ba chanchianiko jegalna kengipa gita niatna nangja. Ramram mandeni krae aganani gadangko ba uamangni English niamo aganani gita "Clapham omnibusni kosako gadogipa mande" ingipa gita niataniko dakna nanga.

12. Ia Kachari, **Pravasi Bhalai Sangathan v. Union of India & Ors**<sup>5</sup> mamlao, Canadian Supreme Court-ni **Saskatchewan (Human Rights Commission) v. Whatcott**<sup>6</sup>-ni mamlana chanchianiko janapchapaha. Ua hukumo, Canadani Supreme Court mitchie aganako champengna niam tarigimin gita maiko "mitchiani" ine channa man'na uko rai on'aha. Kachari-ni skanggipa dakna nangara mitchie aganako champenganiko name mikkang nigija niatchengani aro uko dakengon chanchina changgipa mandera, obostako u'ie chelchakako man'gipa dolko mitchina gita parakenga ine niatgenma uko chanchina nanga. Gnigipa nichengna nanganiara, niam tarigimino "mitchiani" ingipa kattako orto pe'ako rakkiani, jeon gisiko chanchiako agrepilgipa kattaranchi paraka gita janapani jekai "sakoba agrepile mitchia" aro "sakoba ong'siatna kragija aganani ba seani". Iako aganachi nangko namen namnikgijako, ka'onangatako aro gisik saatako

champenggen, indiba nidikatachi, ra'chakgijachi aro jegalachi ma'ekatani ba saknaatniko ong'atanina sokatjawa. Gittamgipao Kacharini u'ina nanganiara ong'a obostako parakaniko name nichengani, mongsongbate, indakachi namgija dakgipa manderangko parakani ong'genma ba dol gipinrangchi mitchiako man'china dakengama. Saniba kamko namnikgija gisiko dongako parakaichide sasti on'ako man'na gita dosko ong'atna chu'ongja.

13. Ia ong'enggipa mamlao, ia Kacharini kosako on'gimin niamko ja'rike, chingni chanchianina sing'ani ong'kataniara, 04.07.2020 tariko Facebook-o post ka'ara jatsa jatgipinko mitchigrikatna miksunge dakama aro jatgnini gisepo bobil ong'grikatna chol gnangma. Facebook post ka'ako namedake niode non-tribal chadamberangko doka satao dos dakgiparangko Meghalaya-ni Chief Minister, Director General of Police aro biapni Dorbar Shnong-ni mamungkoba jako ra'e kamko ka'na gisiko nanggijanina Mol'molaniko dakgipani gisiko duk man'e parakani ine nikgen. Mol'molaniko dakgipa 1979 bilsio non-tribalrangko dokaniko janapaha. Batbee aganoba, Facebook post-ara Meghalaya A'doko donggipa non-tribalrangni kosako changale daka kamkosa mesokna daka ine ma'sina man'a, Indake ong'oba, Mol'molaniko dakgipa dos dakgiparangnade jat ba ma'mal dongja aro basketball kal'gipa non-tribal chadamberangko ka'namgija dokgiparangko ta'raken jako ra'e kamko ka'na nanga ine talataha. Facebook post-ko name chu'gimik poraiode, Meghalaya A'doko songdonggipa non-tribalrangko apsan dake ra'na nanga ine mol'molanisan ong'a. Chingni ma'sianio, Mol'molaniko dakgipara jatsa jatgipinko mitchigrikatna miksungani dongja. Jatni manderangko ding'doate golmal ong'atna Mol'molaniko dakgipa mamung jotton ka'a dongjani gimin, Section 153A aro 505(1)(c)-ni ning'o on'sogiminrang gita dos daka ine ga'akna nanganiko nikjaha. Jeon potaniko FIR ba Matnanganio (Complaint) ra'baaha, uarangko nimrake chu'gimik ra'chakgenchimomangba, matnangako man'gipa-ni kosako mamung dos dakaniko mamlako niarian (*prima facie*) nikjahani gimin, FIR-ko jegalna ga'akaha<sup>7</sup>.

14. India-ra bang'bea bringimin jatrangni songdongram ong'a. Preamble-o janappipa, jakgitele janggi tangna man'aniko on'ania, dingtang dingtang niamrango parakaha jean songdonggipa sakanti manderangna bilko janapaha; uarang jakgitele aganani bil, jakgitele songreani aro (tarigimin niam chongmoto mainaba champengana agre) India-ni je bakoba

songdongna man'aniko man'gopa. Iandakgipa obostarango, saknaatako man'giparang kusi ong'gijaniko ku'rang on'ode, aro parake aganode, mongsongbate a'songko chalaigiparang mikron nikja dake namrengode ba ja'ako apjite dongode, indakgipa kusi ong'gijaniko ku'rang on'aniara kakket dakako man'gijanina ba ru'utatanina ka'onange grape a bokani ong'a. 15. Sakdok songdongkamgijagipa manderangko, mikkang ku'sik ka'tippiparangni dokaniko, A'dok jechakjaha; iako see parakatakoba ong'ja ine jejaha. Kakketko aganode A'dokan songbad-o gatataha (Press Release). Sing'sandianiko dakanio mamung dingtanganiko nikani dongjachim. Mol'molaniko dakgipani agananiara A'dok gimiko jatsa jatgipinrangko golmal ong'atna didiatani ong'naba donga ine Lawsohtun, Dorbar Shnong-ni matnanganiara chanchiako banaie agananisan ong'aia. Meghalaya A'doko songdonggipa non-tribalrangni naljokanina aro uamangni apsan apsan bilko man'paanina Mol'molaniko dakgipani gisiko nangbee bi'aniko mamung dakeba chanchie mitchie aganani ine chana man'jawa. Ian kakketko dakchina mol'molani ong'a- niamo gita kamko ka'china, jekon songdongenggipa sakanti kadongchaksona aro parakna bil donga. Sorkarini kam ka'gijaniko namnikgija aganana dingtang dingtang jatrangko mitchigrikatna jotton ka'a ine aganna man'ja. Jinmako golmal ong'atna miksunge dakjaskal, ka'namgijagipa mamlarango (criminal case) uarangko man chapate ia a'songni songdonggipa manderangni jakgitele agananiko champengna man'jawa. Kosako ra'chakbagimin gita, Mol'molaniko dakgipani Facebook post-o ka'ako namedake sandie nion Section 153 A aro 505 (1) (c) IPC-o dos galna gita Mol'molenggipani kosako mamung mamlakoba nikjaha.

16. Janapgimin a'selrangni gimin, Mol'molaniko ra'chakaha aro Chubatgipa Kacharini (High Court) raiko ra'gale galataha. Laban Police Station-o segatgipa FIR PS Case No.72 (7)2020 tarik 06.07.2020-ko jegalaha.
