

# THE HIGH COURT OF MEGHALAYA AT SHILLONG

## STANDING ORDER NO.18

Dated, Shillong, the September, 2015

No.HCM.II/148/2015-Estt/ : For statistical purposes it is hereby notified to all concerned that the High Court of Meghalaya at Shillong will count the main cases only towards pendency and arrears. Interlocutory applications (Misc. applications) will continue to be separately numbered in original proceedings before the High Court exercising its original jurisdiction and while tabulating pendency and arrears only main cases will be counted and the interlocutory applications arising therefrom will not be counted with immediate effect.

This issues with reference to Resolution No.[3](iv) adopted in the Chief Justice's Conference, 2015 held on 3<sup>rd</sup> & 4<sup>th</sup> April, 2015 in the Supreme Court of India.
