

THE HIGH COURT OF MEGHALAYA: SHILLONG

CIRCULAR

NO.HCM.III/166/2019-Judl./Part-1/271

Dated Shillong, the 23rd April, 2021

In view of the current second wave scenario of the rapidly rising COVID-19 cases in the State, only "extremely urgent" matters shall be taken up w.e.f. Monday, 26.04.2021 till Monday, 10.05.2021, or until further orders, whichever is earlier. The following measures shall be adopted in this regard:

1. An application giving cogent and justifiable reasons for listing of "extremely urgent" new matters may be sent to the Joint Registrar(Listing);
2. A Ld. advocate praying for urgent listing of a pending matter under the "extremely urgent" category shall also be required to provide cogent and justifiable reasons and shall inform the opposite party and /or their advocate(s) well in advance;
3. Whether or not a matter (new or pending) is considered as "extremely urgent", shall be determined by the Hon'ble, the Chief Justice, depending on the facts/merits of the case.
