

Inauguration of Refurbished ASD Lab and New Data Centre in Punjab and Haryana High Court






On 11.08.2024, the renovated ASD Lab was Inaugurated by Hon'ble Mr. Justice Surya Kant, Judge, Supreme Court of India. The lab is protected by a biometric and RFID card-based authentication system, along with an IP surveillance system featuring IP dome cameras for comprehensive monitoring. In addition to the ASD Lab renovation, a new Smart Row system was installed in the Data Centre. This system is equipped with an integrated UPS, fire extinguisher, and online surveillance, offering robust security for high-end SAN

storage, servers, backup appliances, and an automated tape library. The facility is designed for uninterrupted operations with long battery backup, automatic generators, and various safety including measures, temperature and humidity sensors, rodent repellents, a gas-based fire suppression system, and a water leak detection system. The Lab has been fully refurbished embracing future of technology and becoming epitome the of technological innovation and advancement.

Punjab and Haryana High Court Launches ePass Portal



ePass is an initiative launched by the Punjab and Haryana High Court to facilitate a smooth and efficient obtaining paperless process for ePasses necessary for visiting the court for official or case-related matters. This platform incorporates advanced features designed to cumbersome the eliminate procedures typically involved

making visit requests. The primary aim of this document is to outline the workflow for visitors and litigants on the ePass portal, along with the related processes. This system ensures that visitors and litigants can easily apply for and receive ePasses, thereby streamlining the overall visitation process to the Supreme Court of India.

Pinarayi Vijayan inaugurated Special Courts Ernakulam and Alappuzha, dedicated to addressing cases under the SC & ST Act 1989 and the Banning of Unregulated Deposit

Schemes Act, 2019. The event was graced by Hon'ble Mr. Justice Rajesh Bindal, Judge, Supreme Court of India and Hon'ble Mr. Justice C.T. Ravikumar, Judge, Supreme Court of India, and A. Muhammad Mushtaq, Acting Chief Justice, High Court of Kerala.


Free legal aid: Providing the landslide victims access to legal support at no cost.

TWARIT (Transmission of Warrants and Summons and the Report by Information Technology) Program For District Judiciary of Rajasthan High Court





processes. Traditional methods of serving warrants and summons often lead to delays in case resolution. There could not be an occasion better than the concluding ceremony of commemoration of Platinum Jubilee of Rajasthan High Court with gracious presence of a galaxy of dignitaries including Hon'ble Prime Minister of India, Hon'ble Judges of Supreme Court of India, Hon'ble Governor of Rajasthan, Hon'ble Chief Justice & Judges of Rajasthan High Court among other dignitaries. This initiative leverages Information

Communication Technology and (ICT) to integrate diverse systems with tireless efforts of technical team of Rajasthan High Court and under the exclusive supervision guidance of Hon'ble Mr Justice M.M.Shrivastava, the Chief Justice Hon'ble Mr Justice Dinesh Mehta, Chairman Steering Committee, Rajasthan High Court, revolutionising how we manage court warrants and summons. After a successful pilot of the project in 4 judgeships, viz., Sirohi, Jaisalmer, Sawai Madhopur and Hanumangarh over a period of time, the experience has been replicated across the State Rajasthan through necessary enablement vide procedural Gazette notification "The Rajasthan Electronic **Processes** (Issuance, Service and Execution) Rules, 2024" 16.08.2024 issued by dated Government of Rajasthan. initiative, a conglomeration of CIS,

CCTNS, ICIS, and NSTEP, focuses on the speedy electronic delivery of warrants and court summons, timely ensuring hearings decisions. Mobile phones have been provided to bailiffs and process servers, allowing real-time tracking of warrants and summons through a dedicated Mobile App. All electronic documents are accessible through a application. This data web instantly transmitted to a central system and subsequently shared with the Court Information System (CIS). This seamless integration enables courts to monitor service status and make informed decisions promptly. This e-Initiative represents significant leap forward in the quest for efficient and transparent justice delivery. It embodies a commitment to harnessing technology to enhance the effectiveness of judicial processes and to ensure that justice is served swiftly and fairly.

CIS 4.0 Implementation on Pilot Basis at the Udaipur Court Complex at High Court of Tripura, Agartala


High Court of Tripura Conducts eCommittee Outreach Programme for Advocates & Advocate Clerks



Procurement of Hardware under Phase-I and Phase-II of eCourts Project: Under Phase-I & II of the the *e*Courts Project, following Hardware items were procured by the High Court after observing all formalities-All-in-One Desktop Computers, Desktop PC, Thin Client PC, Slim Client PC, Online & Offline UPS, Printers, Scanners, VC Units, Servers, Pedestal, Servers, Rack Kiosks, Diesel Generator Set,

Mobile Handsets, Laptops, Networking Devices, Electronic Display Boards, Projectors with Disk. Screen, External Hard Implementation of e-Filing Version 3.0 in the District Judiciary of Tripura for Digital Filing of cases: Implementation of e-Filing Version 3.0 in the District Judiciary of Tripura for Digital Filing of cases was successfully done under Phase-II of the eCourts Project.

Utilization of Funds:



Under Phase-II of the eCourts Project, the High Court of Tripura utilized an amount of ₹17,57,92,534/- and the total utilization percentage is 98.43% of the total funds received.

Installation of Justice Clocks in 3 Court Complexes of Tripura:



Scanning and Digitization of Judicial Case Records of District Court(s) of Tripura as well as High Court of Tripura was successfully started and the said project has been outsourced to a Vendor after observing all formalities. As on date, 4,17,775 nos. of pages of District Court Records and 43,00,000 of pages of High Court Records have been successfully scanned and digitized.

Inauguration of eSEWA KENDRAS in the District Judiciary of Tripura:



On 23.12.2020, Hon'ble Mr. Justice Sharad Arvind Bobde, the then Chief Justice of India had inaugurated the eSewa kendra at the Registry of the Court of Tripura. High 13.09.2021, the newly established eSewa Kendra at the Court Complex of District & Sessions Judge, West Tripura, Agartala and on 01.10.2021, the eSewa Kendras at Udaipura Court Complex of Gomati Judicial District and Sonamura Court of Sepahijala **Judicial** Complex District of Tripura inaugurated by Hon'ble Mr. Justice Akil Kureshi, Chief Justice, High Court of Tripura in the presence of Hon'ble Mr. Justice S. Talapatra, Judge, High Court of Tripura and on 29.01.2022 Kendras three eSewa were inaugurated at the Court Complexes of Sabroom, Belonia and Bishalgarh by Hon'ble Mr. Justice S. Talapatra,

The eSewa Kendra at the Registry is fully paperless being equipped with four counters and each counter has one All-in-one Desktop Computer, high speed scanners and LAN having access to CIS.





the High Court of Tripura will offer users a convenient and hassle-free experience. The aim of the App is to provide enhanced convenience to all stakeholders involved in the Justice Administration System. The mobile application will replicate all the functionalities of the official website of the High Court of Tripura.

Creation of QR Code Zone in the Lobby of the High Court of Tripura:



A dedicated QR Code Zone has been created and made functional in the lobby of the High Court of Tripura, Agartala. The said QR Code Zone has been designed and developed by the in-house technical team of the High

Court. All the QR Codes containing links to eFiling portal, ePayment portal, Android App of High Court and official Telegram Channel of High Court are displayed on a smart screen. It is designed for the

convenience of all stakeholders, particularly the litigants and lawyers. It enables quick access to IT Services. It ensures access to essential information, thereby improving the overall experience of all the stakeholders.

Development of Paperless Registration System: A Paperless

Registration System module has been developed by the in-house technical team of the High Court of Tripura for registration of participants during

the Seminar "Cross Border on Organized Crimes (NDPS, Human Trafficking & Terror Funding etc.) -**Impact** Assessment and Legal organized Solutions" by Tripura Judicial Academy under the aegis of High Court of Tripura on 29th July, 2023. This application facilitates the event organizer for keeping the record of all the registered participants in electronic mode along with the e-Certificate generation facility.

Live Streaming of Proceedings of Full Bench of the High Court of Tripura:



On 26.09.2023, for the first time, the proceedings of the Full Bench of the High Court of Tripura were successfully Live Streamed on the official Youtube Channel of the High Court of Tripura. The said live-streamed video has garnered 33,000 views (approx.) so far.

Mandatory e-Filing of all Bail Applications in the High Court of Tripura: The High Court of Tripura has implemented mandatory e-Filing of all bail applications through e-Filing portal with effect from 01.09.2023. The notification to this effect was issued on 17.08.2023.

Preparation of SOP relating to VC/ Virtual Hearing before the High Court of Tripura: For availing of easy access to Hybrid/Video Conferencing Hearing, the High Court of Tripura has been pleased to Standard Operating prepare a Procedure (SOP) and the same has been circulated to all stakeholders.

Implementation of e-Filing 3.0 in the High Court of Tripura: The High Court of Tripura has successfully implemented eFiling 3.0 for filing of all cases at the High Court of Tripura. The portal provides a complete end-to-end solution for online filing of pleadings and various applications/petitions related to Cases. This notified was on 25.01.2024.

Implementation of QR based Contact-free Registration **Application:** The implementation of **OR-based** the contact-free registration process by the High Court of Tripura for the 10th Annual Judicial Conclave is a step towards enhancing efficiency in the registration process. The in-house technical team of the High Court of Tripura developed a user-friendly application that generates QR codes containing attendee's personal information. The application ensures

that the QR codes are securely generated and contain accurate information. Prior to the event, each nominated participant received their unique QR code via WhatsApp and email. This ensured that attendees had their QR codes readily available on their smartphones. A large display screen and a camera were placed at the Reception Desk equipped with QR code scanning capabilities. Upon arrival at the venue, attendees approached the Reception. Attendees presented their smartphones with the QR code displayed to the camera at the Reception Desk. The camera scanned the QR code displayed on attendee's smartphone. The application decoded the QR code and retrieved the attendee's personal information from the encoded data. Once the QR code was successfully attendee's scanned and the information retrieved, the system recorded the attendance of the participant automatically and

displayed the same on a large display screen.

Implementation of Use of CIS generated processes by all Criminal Courts in Tripura: For optimum use and utilization of CIS 3.2 application, the High Court of Tripura has been pleased to implement the available features of CIS for auto generated QR based processes for all the Criminal Courts of Tripura. This automation would save the repetitive work of court clerks whose services may then be better utilized.

Implementation of Data Health Card in the CIS 3.2 by all the Presiding Officer of District Court of Tripura: The High Court of Tripura has implemented the available Data Health Card facility in the CIS 3.2, a very useful feature, which enables the Presiding Officer of all the District & Sub-Divisional Courts of Tripura to check the authenticity and accuracy of data in

the CIS. This feature would facilitate all the Presiding Officers to make necessary corrections in the aberrant entries.

Implementation of Neutral Citation

Project: The High Court of Tripura has successfully implemented the Neutral Citation Project under the overall direction of eCommittee, Supreme Court of India.

Tracking Periphery Module: A periphery module has been developed by the in-house technical team of High Court of Tripura for generating instant report of case records pending for more than 2 years for which the reasons for delay have not been entered by the concerned ministerial staff of the

District & Sub-Divisional Courts of Tripura. This module is being used for effective monitoring and compliance of the direction of the eCommittee, Supreme Court of India for entering the "Reason for Delay" in all cases pending for more than 2 years.

"Impugned Judgement / Order Tracking System Ver.1.0" has been designed and developed by the in-house technical team of the High Court of Tripura. This application facilitates sending of SMS alerts to

the Judicial Officer concerned whenever any Judgement/ Order passed by him/her is confirmed or reversed by the High Court.


Record Room Case Tracking System Ver. 1.0:

MESSAGE

It is, indeed, heartening to note that the e-Committee of the Hon'ble Supreme Court of India is proposing to publish a special issue of the e-Committee Newsletter, highlighting the e-initiatives of the High Courts.

An effective judicial system is an essential and integral part of the rule of law. The prime responsibility of the judicial system is to ensure effective, speedy and inexpensive access to justice to its citizens. Access to justice, which represents the ability of every person to enforce the fundamental rights and freedoms guaranteed by the law, is restricted by several factors. Factors like monetary, cultural or geographical barriers disable certain sections of society from accessing courts. Long distances from Courts, more particularly in a hilly State as ours, also act as a barrier to litigants, accused and witnesses in accessing justice as they are, often, required to undertake day long trips to reach courts, quite often only for the matter to be adjourned. Distances also determine the probability of appealing the decision of a lower Court to a State High Court or to the Supreme Court.

It is where the introduction of Information and Technology becomes vital. It is where the Hon'ble Supreme Court of India, through its e-Committee, is leading the path for implementation of Information and Communication Technology in the judiciary. The use of Information and Communication Technology in courts is playing a pivotal role in transforming the judiciary. The Judicial system is moving away from paper-based procedures to embrace digital technologies. This transition to so-called digital justice is redefining the ways in which justice is delivered. The rise of digital justice offers courts the ability to serve justice with greater efficiency and transparency, at lower cost, while making justice more accessible to all. Unburdened by the old processes and procedures, the justice system of tomorrow promises to be more efficient, fairer and less expensive.

I had the privilege of taking over the reigns of this High Court as its 13th Chief Justice on 04.02.2024. Efforts have been made to achieve optimum utilization of technology in courts, so as to make the justice delivery system accessible, cost-effective, transparent and accountable. Various activities have been undertaken under the e-Courts Project under the abled guidance of the e-Committee of the Supreme Court of India. We have also implemented automation of the mediation process through WhatsApp, so that parties do not have to travel long distances for settling their disputes. Under the said process, we have decided to create a WhatsApp Group for each case, which would serve as a medium to automate, share and access all the information regarding mediation activities in the High Court and the District Courts. The Registrar, who is In-charge of the Mediation at the High Court; the Secretary, High Court Legal Services Committee; and the Secretaries of all the District Legal Services Authorities, have been authorized to automate the process of mediation through WhatsApp group. The empanelled Mediators of the High Court and the District Courts have also been directed to create separate WhatsApp groups for each case referred for mediation and to update the proceedings of the said case on daily basis in the said WhatsApp group. The Court is also in the process of engaging Psychologists, who can interact with the litigants and children in the Family Courts. These Psychologists will also be available for interaction with the parties through WhatsApp Group.

While all these initiatives will ultimately prove to be a steppingstone in transformation of the judicial system, the dissemination of information on these initiatives, amongst the various stakeholders and the litigants, who are the ultimate beneficiaries, is equally important. This is where the initiative taken by the e-Committee of the Hon'ble Supreme Court of India to publish the Newsletter, highlighting the e-initiatives taken by the High Courts, achieves significance.

Achievements of Phase I and II of the e-Courts project of the High Court of Uttarakhand

Computerization Work Done **Under Phase:** In the Phase-I, computer rooms and judicial service centers have been set up in 30 court of complexes. Out 53 court complexes the in State, preparation of Computer Rooms (CSRs) and Judicial Service Centres (JSCs) has been completed in 30 Court complexes, while Hardware and LAN installation has been done at 26 Court complexes in Phase-I and Phase-II of the eCourts project.

Installation of LAN, Computer hardware and DG Set in Court complexes: Under Phase-I and Phase-2 of eCourts Project, Local Area Network (LAN), installation of Computer hardware and DG Set work has been completed at 26 court complexes as per the guidelines issued by NIC, New Delhi.

Implementation of CIS 3.2 and uploading of Data on NJDG portal:

National Core (NC) CIS 3.2 has been installed across the computers in Court complexes. Presently the CIS is functioning at (includes 52 Court Complexes and 29 other complexes of 01 FTC-Dehradun, 01 Commercial Court Dehradun, 16 Family Courts, 11 Juvenile Justice Board. Data of cases is being entered in CIS 3.2 which is further being uploaded on the National Judicial Data Grid (NJDG) portal for the use of stakeholders.

Installation of Video-Conferencing units: Under Phase-II of eCourts Project, the video conferencing hardware has been installed at 52 court complexes and 132 courts of Uttarakhand.

Connectivity **Internet** at Subordinate Courts: Internet Connectivity is being provided at 11 District Courts through leased line. A total of 30 Court complexes in present are being provided internet connectivity through VPNoBB. Wide Area Network (WAN) connectivity has also been provided at 52 Court complexes of Uttarakhand on the directions of the Department of Justice, New Delhi.

Unique identification numbers for Judicial Officers: Unique identification numbers have been provided to each Judicial Officer. The said numbers are being used to enter the data of the court relating to the Judicial Officers in the CIS software which is, thereafter uploaded on National Judicial Data Grid.

Judicial Officers cum Nodal
Officers for Computers: One
Judicial Officer as Nodal Officer
(Computer) has been nominated at

each District. The Nodal Officer (Computer) is responsible monitoring and updating of data on the National Judicial Data Grid (NJDG) portal and for monitoring entire computer related activities. In addition, District System Administrators are nominated to assist the Nodal Officer in every district with relation to above responsibilities. System officers and assistants have been appointed in the Districts, to manage/support computer works in the Districts.

Process Re-engineering: General Rules (Civil) and General Rules (Criminal) regarding ICT enablement have been amended by the High Court.

Purchase of Hardware and LAN:
Delivery and installation of hardware
for State Judicial Academy(SJA),
District Legal Service Authority
(DLSA) and the Taluka Legal Service
Committee(TLSC) of Uttarakhand

State under Phase-II had been completed.

Procurement of Hardware under Phase-II: Under Phase-II of eCourts, following hardware for subordinate courts was to be procured for which funds have been received from the Department of Justice/Hon'ble eCommittee, Supreme Court of India.


District Court Websites: District Court Websites are available for all 13 District Courts through eCourts portal, made on S3WaaS.

E-filing: Vide notification no. 394/UHC/Admin.A/2021 dated 31.12.2021, "Uttarakhand Electronic Filing (E-Filing) Rules, 2021" has been notified. E-Filing Version 3.0 facility was initiated at Hon'ble High Court and all the Subordinate Courts of Uttarakhand w.e.f. 17.01.2023.

Interoperable Criminal Justice System (ICJS): The Interoperable Criminal Justice System (ICJS) has

been introduced to facilitate speedy iustice through data-exchange the between courts, police/prosecution, jails the and forensic labs. It has been developed by NIF for the District Courts, prisons and police stations, namely Case Information System, e-Prisons and Kanoon Vyavastha, respectively. The ICIS has also been successfully implemented in police stations of Uttarakhand, where FIR is being consumed in the CIS software of District Courts.

Office Vide E-True Copy: Notification bearing no. 338/UHC/Admin. A/2022dated 03.11.2022, "The Uttarakhand High Court Electronic True Copy Rules, 2022" have been notified. "Electronic True Copy of Orders/Judgments" is a software application developed to provide litigants and the Advocates of the parties, a form to obtain electronic of true copy



orders/judgments available in the National Judicial Data Grid. The procedure to get the aforementioned eTrue copy is available on the official website of Hon'ble High Court of Uttarakhand.

E-RTI Portal: On 19.06.2023, Hon'ble the Chief Justice, High Court of Uttarakhand inaugurated the e-RTI portal. The e-RTI (Right to Information) portal application, only for Indian citizens, that accessed through can https://ertihc.uk.gov.in/. By using the RTI web application, the applicant will be able to file the RTI and First Appeal application at the Hon'ble High Court and District level.

JUSTIS, mobile application:- The JUSTIS app has been installed in the mobile phones of Judicial Officers by which they can access the case pendency and other status of their Courts.

Implementation of SMS Service for Advocates/litigants: SMS service is functional different at court complexes including 52 Court Complexes and 29 other complexes of 01 FTC- Dehradun, 01 Commercial Court Dehradun, 16 Family Courts, 11 Juvenile Justice Board, where CIS 3.2 has been functioning to provide Case information to Advocates regularly. Information /litigants relating to case number, CNR

number, next date fixed and party names are being provided through the SMS.

Automated email service:
Automated email service has been started at subordinate Courts by which the information about the case and the causelist is being sent to the registered email addresses of Advocates/litigants.

Neutral Citation- First Phase of Neutral Citation system was implemented in the High Court of Uttarakhand. Now, a Citation Number' is being generated in every disposed of case, before uploading the final order/judgment. Neutral Citations have also been successfully generated for the entire legacy Judgments/Final Orders of this Hon'ble Court.

National Service and Tracking of Electronic Processes (NSTEP)-: NSTEP has been implemented in all the District Courts. NSTEP Mobile App provided to bailiffs and process servers enables transparent tracking of service of notices and summons in real-time. The bailiffs can view the allocated processes on the NSTEP Mobile App. The bailiffs can capture GPS location, photo of the receiver or premises to be served, the signature of the receiver. The data captured is instantly communicated to the central NSTEP application.

Virtual Courts: On 10.06.2023, Hon'ble the Chief Justice, High Court of Uttarakhand inaugurated a Virtual Court in Uttarakhand for the online settlement of cases relating to e-Challans, under Motor Vehicle Act, 1988 to adjudicate e-traffic challan cases through virtual electronic platform for the entire district of Dehradun. Virtual Court is an operation in District Court Dehradun and District Court Haridwar.

Ongoing Phase III of eCourts Project at High Court of Uttarakhand

Taking the gains of Phase-I and Phase-II to the next level, the e-Courts Phase-III aims to usher in a regime of maximum ease of justice by moving towards digital, online paperless and courts through digitization of the entire court records including legacy records and by bringing in universalization of e-Payments e-Filing/ through saturation of all court complexes with e-Sewa Kendras. The main objective of the Phase-III is to create a unified technology platform for the judiciary, which will provide a seamless and paperless interface between the courts, the litigants and other stakeholders. The expected outcomes of the scheme are as follows:

 Citizens who do not have access to technology can access the judicial

- services from eSewa Kendras, thus bridging the digital divide.
- Digitization of court records lays the foundation for all other digital services in the project. It enables processes to become more environment friendly by minimizing paper-based filings and reducing the physical movement of documents.
- Virtual participation in the court proceedings thus reducing costs associated with court proceedings such as travel expenses for witnesses, judges, and other stakeholders.
- Payment of court fees, fines and penalties from anywhere, anytime.
- Expansion of eFiling for reducing the time and effort required to file documents. Thereby minimizing human errors as documents are automatically checked and also preventing further creation of paper based records.

- Use of latest technologies like AI and its subsets Machine Learning (ML), Character Optical Recognition (OCR), Natural Language Processing (NLP) to provide a smoother user experience by building a "smart" ecosystem. Registries will have less data entry and minimal file scrutiny facilitating better decision-making and policy planning. It envisages scheduling, an intelligent smart that enables data-based system decision making for judges and allows for registries, greater predictability and optimisation of the capacity of judges and lawyers.
- Expansion of virtual courts beyond the adjudication of traffic violation cases, thereby eliminating the presence of litigants or lawyers in the court.
- Enhanced accuracy and transparency in court proceedings.
- Emphasis on automated delivery of court summons by further expanding

- the NSTEP (National Serving and Tracking of Electronic Processes), hence drastically reducing the delays in trials.
- Use of emerging technologies in court processes will make them more efficient and effective, hence contributing significantly towards the reduction of pendency cases.

Installation of Porta Cabins and LAN Nodes in e-Sewa Kendra: Hon'ble eCommittee has sanctioned funds for 40 no. of eSewa kendras with 86 LAN points, for which budget has been released. The work of installation of Porta cabins and LAN is in process at all locations, and it has been assured by the respective Executive Engineer in a meeting held through VC to finish the installation by 15.03.2024.

work of procurement of hardware

Manpower has been allotted to NICSI. The Interim fund, as received from the Department of Justice, has been transferred to NICSI- New Delhi. With regard the to procurement of All-in-one desktop the technical and scanners, evaluation is in progress which is being done by the NICSI. For installation of LAN nodes, the survey has been completed by empanelled vendors of NICSI. On request of NICSI, the updated Proforma Request Form will be submitted to NICSI, on which basis, the PI will be issued and work order will be issued to the qualified bidder. Installation of Solar equipment in Court complexes (By UREDA): Uttarakhand Renewable Energy Development Agency (UREDA) has been requested to visit the 36 sites,



The Interim funds as received from the Department of Justice (DoJ) have been transferred to UREDA for execution of said tasks.

Procurement of Hand-Held Devices and Digital Signature Tokens: 225 hand-held devices were proposed to be procured for process servers and bailiffs in the Districts of State and a budget of Rs. 27,00,000 has been approved by Hon'ble eCommittee for the same. A work order has been issued to supply 702 units of Digital Signature tokens for **Judicial** Officers/Courts Staff of District Courts.

Best Practices of High Court of Uttarakhand

Hybrid or Dual Mode of Hearing of Cases:



In view of the COVID-19 pandemic, hearing of cases in the High Court of Uttarakhand was conducted through Video Conferencing from 15.04.2020 till 31.12.2020. In the present, the hybrid or dual arrangement of hearing has been put in place in all the Courts.

Case Information System, CIS 1.0 Specific to High Courts: Unified Case Information System (CIS 1.0), which was deployed on 04.09.2018 is being used to manage the information of the cases in the High Court. Daily and weekly Cause Lists are made available on the official website of the High Court in PDF format generated through CIS 1.0. Statistical Statements for Sections of the High Court are also available through CIS.

Facility of free Wi-Fi internet in the premises of High Court: The TAC approved estimate of Rs. 93.34 Lakh to provide free Wi-Fi facility to all the stakeholders has been sent to State Government vide letter No. 5961/IT-X/Wi- Fi/2023, dated 21/102023. Consent of the State Government has been received and

the required budget has been transferred to PWD with direction to execute the same at the earliest.

- II. Online Research Services /law libraries like SCC Online and Manupatra have been subscribed to by the library. Digital Law Journals, like SCC Online and Manupatra are also available to each of the Hon'ble Judge of the Court.

Internet Connectivity Status: In the present two arrangements for internet connectivity in the High Court are being maintained. Internet connectivity through a 34 MBPS NICNET connection throughout the High Court by leased line and 50 MBPS MPLS BSNL connection.

Inventory Management System for Stationery & Management office.

Inspection Pendency Report:- It is being used by the Inspection Section of the High Court. This Software is used for monitoring records of District Court including institution,

of Hon'ble Judges.

disposal, and pendency reports from District Courts by the Section.

Online Pendency and Arrears report software: It is used by the Inspection section. This portal keeps the District wise pendency record of CIS data as well as Non-CIS data.

Recruitment Management System: It is developed for the Administrative Section of the High Court as well as the Subordinate Courts. This portal keeps records like vacancy, working strength, sanctioned strength/posts in the High Court and the District Courts.

Court Cause List Software: Software sending list for cause to advocates/litigants The Nodal Officer (Computers) Bageshwar has for now that Public suggested a Announcement System/speaker may be used to make case title calls as the inbuilt system is not adequately loud/audible through automated emails.

DCPMTthe District Court Performance **Monitoring** Tool: DCPMTthe **District** Court Performance Monitoring Tool is an Application Software for monitoring the performance of judicial officers of the State of Uttarakhand. The purely in-house software aims to provide a tool to the Hon'ble Chief

Justice and the Hon'ble Administrative Judges of the High Court of Uttarakhand to monitor the performance of the Judicial Officers of the State on five parameters of the Court work on a daily and monthly basis. The software also enables the High Court to monitor the progress of all the subordinate courts in terms of disposal of every case including special category cases like old cases, cases relating to women, children, senior citizens etc. The tool will also provide the Judicial Officers of the State a platform to monitor their own performance. So as to inspire them to do better every day and to achieve a desirable benchmark of performance in line with the expectation of the High Court.

Online Court Fee deposit: Online Court Fee deposit facility through Stock Holding Corporation of India is available and being used in the High Court of Uttarakhand.

Justice Clock: Justice Clock (RGB Based Display Board) has been installed in the premises of the High Court to display information available in the NJDG.
