- 2. For the purpose of direct recruitment in the Meghalaya Higher Judicial Service and Meghalaya Judicial Service and as remarked by the Hon'ble Supreme Court of India at paragraph 67.1 (vi) of judgment dated 03.03.2025 in the said case,

there shall be no distinction between Persons with Disabilities (PwD) and Persons with Benchmark Disabilities (PwBD).

- 3. A separate merit list is to be published for the PwD/PwBD category at every stage of the examination.
- 4. In the event that a PwD/PwBD candidate is qualified for the interview/viva voce phase of the recruitment process, the interview panel shall comprise of at least one specially-abled person/an expert or person well conversant with disability rights.
