Recruitment to the Post of Grade-III Judicial Officers under the Meghalaya Judicial Service Rules 2006 with Amendments upto 2025

- 1. Online applications are invited from eligible candidates for direct recruitment to 11 (eleven) posts of Grade-III Judicial Officers, as per Schedule B of the Meghalaya Judicial Service Rules, 2006 (with amendments up to 2025), in the pay level J-1 (Rs. 77,840/- per month plus allowances):
 - (i) Khasi Jaintia: 4 posts
 - (ii) Garo: 4 posts
 - (iii) OST/OSC: 1 post
 - (iv) Unreserved: 2 posts

2. Eligibility Criteria

- (i) Must be a citizen of India.
- (ii) Must have a degree in Law from a recognized university established by law in India.
- (iii) Age Limit:
 - (a) General Category: Not above 35 years as of the last date of application.
 - (b) SC/ST: Not above 38 years as of the last date of application.
- (iv) Must have minimum 3 years of practice as an advocate as on the last date.
- (v) Must have a working knowledge of Khasi, Jaintia, or Garo.

3. Reservation

Reservation follows the Government of Meghalaya policy for SC/ST, PwBD, and other categories.

4. Application Fee

General: Rs. 700/-

SC/ST: Rs. 350/-

PwBD: Exempted (with valid certificate)

5. Payment modes:

- a. SBI e-Challan (for cash at any SBI branch)
- b. Debit/Credit Card or Net Banking (State Bank of India)

Payments made after deadline or through other means will not be accepted and fee is non-refundable.

6. Disqualification from Appointment

A candidate will be disqualified if:

- (a) Not a citizen of India.
- (b) Dismissed or removed from any government/judicial/statutory/local authority.
- (c) Convicted of an offence involving moral turpitude or permanently debarred/disqualified by any recruiting authority.
- (d) Found canvassing or influencing the selection process.
- (e) Productions or submissions of false, incomplete or forged documents, or incorrect information.

(f) Fails to fulfill prescribed eligibility at any stage as verified by the High Court.

7. How to Apply

- (a) **Apply online only** through the High Court website: www.meghalayahighcourt.nic.in
- (b) One-time registration is required for first-time applicants.
- (c) Application Window:
 - (a) Opens: 27th October, 2025
 - (b) Closes: 21st November, 2025 (up to 5:00 PM)

(d) Required Uploads:

- (a) Citizenship and age proof
- (b) Law degree and all mark sheets
- (c) Enrollment/practice certificate
- (d) Experience certificate
- (e) Caste/disability certificate (if applicable)
- (f) Two character certificates (not relatives or academic staff)
- (g)One latest passport-size photograph
- (h) Fees: Paid via e-challan (cash at SBI) or SBI Net Banking/Debit/Credit Card.

8. Selection Process

(As per Meghalaya Judicial Service Rules, 2006, as amended)

The recruitment shall be conducted in three stages:

- A. Preliminary Examination (Screening Test)
- B. Main (Written) Examination
- C. Viva-Voce / Interview
- A. Preliminary Examination (Screening Test)

- (i) The Preliminary Examination shall be an **objective-type** (multiple choice) test for 100 marks of two hours' duration.
- (ii) The examination is **qualifying in nature** and meant to shortlist candidates for the Main Examination.
- (iii) Marks obtained in the Preliminary Examination shall **not be** counted for final merit.
- (iv) The number of candidates shortlisted shall ordinarily be **ten times the number of vacancies**, or as determined by the High Court.
- (v) There shall be no negative marking.

Subjects for Preliminary Examination

The question paper shall cover the following areas:

- (I) General Knowledge and Current Affairs Indian polity, history, geography, economy, environment, and current national and international events; awareness of the culture and polity of Meghalaya.
- (II) **English Language** Vocabulary, grammar, comprehension, précis writing, and usage.
- (III) **Reasoning and Analytical Ability** Logical reasoning, numerical aptitude, and problem-solving ability.
- (IV) Law (Fundamental and Procedural Laws)
 - Constitution of India
 - o Code of Civil Procedure, 1908
 - Code of Criminal Procedure, 1973 / Bharatiya Nagarik Suraksha Sanhita, 2023 (BNSS)
 - Indian Penal Code, 1860 / Bharatiya Nyaya Sanhita, 2023 (BNS)
 - Indian Evidence Act, 1872 / Bharatiya Sakshya Adhiniyam, 2023
 (BSA)
 - Law of Contracts and Torts

- General Legal Principles and Legal Maxims
- (V) Local Laws and Customary Practices Basic knowledge of customary laws and local governance systems in Meghalaya.

B. Main (Written) Examination

The Main Examination shall consist of **five descriptive papers** as follows:

C. Viva-Voce / Interview

- The Viva-Voce shall carry 70 marks.
- It aims to assess the candidate's personality, communication skills, legal acumen, and suitability for judicial service.
