U shah mudui uba saw( u Edmund S Lyngdoh) u la kham jied iaka SLP(Crl) No 553/2011 u da beiñ pyrshah iaka jingpynkylla, da kaba rai pyllait saja bad da pypaw ba ka jingai

27. Ha kaba iadei bad kane ka Sanction for Prosecution, la wanrah ka jingiatohkit bad la peit iaka Article 166 jong ka Constitution ka Ri India bad ka ingbishar ka la pynkut ba ym don daw ban ym biang ka Sanction.

28. la don ruh ka jingpypaw ba la ia ka case ha ka por ba la slem por bha jin haduh 2(ar) snem hadien jong ka 1982, ha ka ba u Vice Chancellor B.D Sharma u la phah ujor ha ka 03/07/1985 ia kane ym shim la ñiew namar ia u ym shim la wanrah kum u sakhi.La pynshai ia kane ba ia ka DPC (Dam seal) la ai naduh 1982-1985.

29. Kat kum ka Contract ka jingai iaka Dam seal ka la long naduh 1982 haduh 1985 bad ka jingai mudui da u Vice- Chancellor kam ktah satia ia ka Mukotduma.

30. Ka jinglong ka ba don bad kane ka ujor kam iadei- iahap bad kum kiwei pat ki ujor ai mukotduma, kumta ka Bishar hehduh ka la kyntait ia kane ka jingpynsngew.

31. Ka ingbishar khliehduh da kaba bishar pynshong ia ki kot ki sla bad ki sakhi satar ba la wan na ka High Court bad ka ingbishar ba kham hapoh ka la lap bad shem ba ki ingbishar ba hapoh ki la rai hap biang ha jinglap jingshem jong ki.
